4a (Code:) (Expenses \$ 609,515 including grants of \$) (Revenue \$) In 2012, the SFBC Education Fund continued to step up its programs to educate bicyclists about safe riding, as well as reaching out to motorists about safe driving. We helped grow the city's Safe Routes to School program, working closely with the SF Department of Public Health and other partners, to reach kindergarten and first graders in 15 local schools with the message of safe walking and biking. We also organized and led the city's fourth annual Bike to School Day with approximately 2,000 people participating. We launched a new Family Biking program that included a free Family Biking Guide in three languages and a four-track family biking class series. Throughout the year we hosted free Urban Cycling Workshops, teaching hundreds of adults how to be confident, safe, and respectful when biking on city streets. These classes, in partnership with the SF Municipal Transportation Agency, help promote safe streets and biking in San Francisco.

4b (Code:) (Expenses \$ including grants of \$) (Revenue \$) (Continued from above) We expanded our ongoing promotion of bicycling in 2012, making it easier for more people to try bicycling as a safe, affordable, healthy, and convenient way to move around. Our successful outreach events include Bike to Work Day, in which tens of thousands of people try biking, and regular Energizer Stations, in which we recognize and celebrate people who are already biking. We also used donated billboard space in high profile locations around the city and a dedicated new rider section of our Web site to invite people of all backgrounds to "get rolling."

4c (Code:) (Expenses \$ including grants of \$) (Revenue \$) (Continued from above) In 2012, we continued to be a core partner in San Francisco's growing Sunday Streets program. We organized hundreds of volunteers for each of the regular events, which open up streets to people for healthy activity such as bicycling, walking, and skating by closing them to cars for a few hours on Sundays. We are proud to have helped San Francisco become one of the first major North American cities to launch such a program, and today continue as a core programming partner and the lead volunteer organizer, which includes recruiting, training, and managing hundreds of volunteers for each event.
